

# Privacy Policy

## “Modest Movement”

1. This privacy policy applies between you, the User of this Service/Website and ‘Modest Movement’. The owner and provider of this Service/Website is Modest Movement, a limited liability partnership registered in United Kingdom. “Modest Movement” is a data controller and takes the privacy of your information seriously. This privacy policy applies to our use of all Data collected by us or provided by you in relation to your use of our Service/Website

2. In this privacy policy, the following definitions are used:

### Definitions and interpretation

Data	Collectively all information that you submit to ‘Modest Movement’ via the Website. This definition incorporates, where applicable, the definitions provided in the UK GDPR.
UK GDPR	UK GDPR means Regulation (EU) 2016/679 General Data Protection Regulation as it forms part of the law of England and Wales, Scotland, and Northern Ireland by virtue of section 3 of the European Union (Withdrawal) Act 2018 and amended by the Data Protection, Privacy and Electronic Communications (Amendments etc.) (EU Exit) Regulations 2019.

3. In this privacy policy, unless the context requires a different interpretation:

- a. the singular includes the plural and vice versa.
- b. references to sub-clauses, clauses, schedules, or appendices are to sub-clauses, clauses, schedules, or appendices of this privacy policy.
- c. a reference to a person includes firms, companies, government entities, trusts, and partnerships.
- d. "including" is understood to mean "including without limitation".
- e. reference to any statutory provision includes any modification or amendment of it.
- f. the headings and sub-headings do not form part of this privacy policy.

### Scope of this privacy policy

4. This privacy policy applies only to the actions of “Modest Movement” and Users with respect to this Service/Website.

5. For purposes of UK GDPR, ‘Modest Movement’ is the "data controller". This means that Name determines the purposes for which and the way your Data is processed.

## **Data retention**

17. Unless a longer retention period is required or permitted by law, We will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.

18. Even if 'We' delete your Date, it may persist on backup or archival medial for legal, tax or regulatory purposes.

## **Your rights**

19. You have the following rights in relation to your Data:

- a. Right to access- the right to request (i) copies of the information We hold about you at any time, or (ii) that We modify, update, or delete such information. If We provide you with access to the information We hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where We are legally permitted to do so, We may refuse your request. If We refuse your request, we will tell you the reasons why.
- b. Right to correct- the right to have your Data rectified if it is inaccurate or incomplete.
- c. Right to erase- the right to request that We delete or remove your Data from our systems.
- d. Right to restrict our use of your Data- the right to "block" us from using your Data or limit the way in which We can use it.
- e. Right to data portability- the right to request that We move, copy or transfer your Data.
- f. Right to object- the right to object to our use of your Data including where We use it for our legitimate interests.

21. If you are not satisfied with the way a complaint you make in relation to your Data is handled by us, you may be able to refer your complaint to the relevant data protection authority. 22. It is important that the Data We hold about you is accurate and current. Please keep us informed if your Data changes during the period for which We hold it.

### **Changes of business ownership and control**

23. 'Modest Movement' may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of 'Modest Movement'. Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.

24. We may also disclose Data to a prospective purchaser of our business or any part of it.

25. In the above instances, We will take steps with the aim of ensuring your privacy is protected.

### **General**

26. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where We reasonably believe your rights will not be affected.

27. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.

28. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

29. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
